THERE WERE A TOTAL OF 28,076 CLIENT VISITS DURING FISCAL YEAR 2025.

LOUIS WITH SERVICES AT THREE LOCATIONS. THERE WERE A TOTAL OF 9,930 ANIMALS SERVED DURING FISCAL YEAR 2025.

TWENTY-FOUR HOURS A DAY, 365 DAYS A YEAR, HUMANE OFFICERS FROM THE ANIMAL CRUELTY TASKFORCE (ACT) RESPOND TO COMPLAINTS OF ANIMAL CRUELTY OR ABUSE.
